- 5. To meet with the policing team recently assigned to the local area.
- 6. To open the meeting to members of the public to enable them to address questions to Parish Councillors. The period of time which is designated for public participation shall not exceed 20 minutes. Each member of the public is entitled to speak once only in respect of business itemised on the agenda and shall not speak for more than 3 minutes. A question asked by a member of public during public participation session at a meeting shall not require a response or debate.

- 9. Receipt of nomination to existing committees and election of Chairman to Committees
