#### HPC 001/23/24 TO RECEIVE AND APPROVE APOLOGIES

Apologies were received from Cllr A Forbes, Cllr B Raymond, Cllr R Veitch and Cllr Mrs I Weeks. No apologies were received from Cllr P Beck.

County Cllr Mrs Marge Harvey gave her apologies for the meeting.

A report by the RFO was circulated and noted. The RFO said that the Napier Hall income was higher than expected pre-covid, with the overall hall income coming in at over 80% for the year.

#### HPC 010/23/24 TO RECEIVE A REPORT AND CONSIDER THE QUOTATIONS AND FUNDING IN RESPECT OF THE INSTALLATION OF SOLAR PANELS

A report by Cllr Teresa Attlee was circulated and it was mentioned that it would be financially beneficial to have solar panels installed. A discussion took place. Cllr Lay thanked the working party for producing a fantastic report.

#### It was **<u>RESOLVED</u>** that

- Council award the contract to supplier 3 Solar Powerful, total cost £25,000 plus VAT.
- Funds are made available for this project from the Future Developments Earmarked Reserves.

## HPC 011/23/24 TO RECEIVE AN UPDATE IN RESPECT OF THE GREEN AND HERITAGE NETWORK TRAIL PROJECT NETWORK TRAIL PROJECT

An update was provided to members, with Cllr Lay stating that the project would be run in partnership and with support from EHDC and a number of other groups and bodies.

# HPC 012/23/24TO RECEIVE AND CONSIDER THE QUOTATION IN RESPECT OF THE<br/>COMPLETION OF A FEASIBILITY STUDY PERTAINING TO THE GREEN AND<br/>HERITAGE NETWORK TRAIL

A report by Cllr Lay was circulated and it was confirmed that there was already 6.5k in the HPC bank account, with 17k having been applied for from ClL. It was proposed and agreed to stand down standing orders so that a further two quotations were not required.

It was **<u>RESOLVED</u>** that HPC approve the use of Urban Place Lab to undertake the feasibility/Scoping Study, at a cost of £23,500, plus expenses (anticipated at £500 or less).

## HPC 013/23/24TO RECEIVE THE RECOMMENDATION FROM THE GROUNDS COMMITTEE ON<br/>THE 20 MARCH 2023, IN RESPECT OF THE REPLACEMENT OF PLAY<br/>EQUIPMENT AT FIVE HEADS RECREATION GROUND

Cllr Tickell informed Council that the previously agreed quotation from Jupiter Play & Leisure did not include the installation cost. The installation cost has now been added to the original quotation and it was **RESOLVED** that Council accept the new quotation at a cost of £2,997.00.

#### HPC 014/23/24 TO RECEIVE THE RECOMMENDATION FROM THE GROUNDS COMMITTEE ON THE 20 MARCH 2023, IN RESPECT OF THE INSTALLATION OF A WATER SUPPLY TO DELL PIECE WEST

A discussion took place and It was <u>**RESOLVED**</u> to proceed with the installation (Portsmouth Water) of a water supply to Dell Piece West, total cost of £2,093.00 + VAT.
