SUBJECT TITLE: Shed for the Countryside Team Compound

PURPOSE OF REPORT: Since moving into the new building at Jubilee we have managed the move very well into the new workshop and have found a home for most items.

One issue we have is long-term storage of specific items. Up until recently, we had stored some items in one of the changing rooms but this has now been cleared. We do still have some grit (for icy days stored in the changing rooms as this can't be left outside, some tables sat outside in the compound and we have a number of hand tools stored in a wheelie bin outside while we have 3 wheelie bins inside the workshop.

The inside of the workshop is at capacity and we have some items like signage, rakes, hand tools etc just propped up against walls/tucked in corners.

I believe the installation of a shed in the compound would ease any current and future storage issues that may occur and help keep the workshop in a clean and safe state by reducing potential Health and Safety issues such as trips and items falling.

No power tools would be stored in a shed, they would all stay in the workshop. A shed would solely be for hand tools, seasonal items and low usage items.

A 6 x 8 shed would range in price from £500 to £1000 depending on quality. For longevity, it would be better to purchase a good shed. A timber frame for the shed to sit on may also be required as this reduces the risk of the shed base rotting.

SUBJECT TITLE: Fire Site

PURPOSE OF REPORT: The Parish Council spend around £1000 £1300 annually of disposing of green waste. I am aware in the past of council members asking if these costs could be reduced.

One option I have seen could be to install a fire site at Parsonage Field. I suggest this site for a number of reasons. Access should not be a problem, it is flat, and there is a neighbour who has his own fire site in the very next field so local residents are used to fires burning green waste in the area.

While Parsonage field is a wildflower meadow, the one section where the fire site could go is in the southeast corner as you enter the field. This is a small section of the field that annually gets overgrown with brambles. Some wildflower does grow here, but it is not the main meadow area.

While there are issues with this location being a fire site, if reducing the cost of green waste disposal is a serious concern, I cannot think of any other locations as suitable as here.

If a fire site was to become an option, it would need fencing off with an access gate (for public safety) and possibly some hard standing material such as type 1 for vehicles to drive on. There would be an initial financial outlay to create a suitable area.

Regarding Biomass – this in my opinion is a non-starter. We do not produce the amount or type of material suitable. Overall we produce hedge cuttings and branches. Some timber is available when we fell trees etc but most timber we try to use/stack as log piles. We do burn small amounts with volunteers as they clear through brash/bramble.

Overall, any substantial deadwood is vital for wildlife and should not be removed off site.

(An exception was made when we felled Ash at Catherington Lith due to the large amounts of timber. Some was left on site and some was removed for firewood - this was discussed with the Forestry Commission at the time and was priced into the quote).

SUBJECT TITLE: Planting of Pyracantha hedge around the windows at Jubilee Hall

PURPOSE OF REPORT:

According the RHS, planting of Pyracantha for a hedge needs to be spaced at 50cm apart.

We have measured and priced up to replant the areas where the Yew trees currently are - the West and North-West window.

To plant along the borders and fill the beds where the Yews are planted will require 50 hedging plants at a total cost of £449.50

Are council happy for us to proceed with this?

If possible, I would like to remove any healthy Yew trees and replant them in our woodlands at Catherington Lith and Yeolls Copse. Yew makes a nice woodland tree and this species is found across our woodlands.

POTENTIAL PROJECTS FOR HORNDEAN

Convert the Jubilee Basketball area into a Muga – Multi Use Games Area.

This will provide a better more varied all weather play/sport facility for local childeren/teens etc.



Footpath Improvement around Hazleton Common

In the most recent management plan for Hazleton Common I made mention to the potential impact of increased visitor numbers from Land East of Horndean on the nature reserve. The main perimeter track around Hazleton is just a grass path that becomes very wet and muddy over winter. Putting in a hard surface could potential reduce potential long term damage to the nature reserve from the increased footfall.

This would be a large project.

Footpath Improvement at Cath Lith

A section of footpath at Cath Lith between the Donkey House and the equine fields (heading towards the Church – North section of the Lith) is in need of an upgrade.

Purchase the land where the Colonial Bar Stood

This is an eye sore and nothing has happened here as long as I have worked with the Parish. This area could be used for a number of things. Examples are:

extend car parking for Napier Hall 2. create a public garden 3. move the war memorial as
the current location is becoming too small for the number of people that attend Rem Parade
4. skate park/bmx for local children 5. Community allotments 6. Crazy golf course.

Improve the surround area around the car park at the top of Horndean/London Rd.

Landscape the surrounding car park to make it more aesthetically pleasing. It would improve the look of the village.

Purchase a plot of Land for the Countryside Team to have a fire site

The Parish Council spend approx. £2000 a year on burning green waste. Purchasing an area could in the long run save the council money.

Tarmac a complete circular path around Jubilee Playing Field

Half of the park has a tarmac surface. Creating a circular route could be something beneficial to people with disabilities/wheelchair access etc

SUBJECT TITLE: Five Heads Hedge

PURPOSE OF REPORT:

Following on from a report I took to Council in July 2021 regarding the lowering and restocking of the Hedge along the boundary at Five Heads Rec I was asked to contact the residents to get their opinions/feedback on the proposal.

I have attached a copy of the letter I sent.

Feedback has been mixed, with two households stating they would be happy for the hedge to be lowered to my recommendation, two households saying they don't want it lowered and one household saying a small reduction to match the neighbours would be acceptable. Three households made no comment.

The comments received are below:

- I totally agree with suggestion, it's upsetting to see an ancient hedge being lost. It is a hive of activity for wild life, blackbirds nest every year, the birds, butterflies take the nectar, pollen, the bats eat the flying insects, the birds eat the berries in winter. A whole eco system. We do not want to loose this natural environment. (Number 8 Princess Gardens)
- Thank you for the letter that was hand delivered yesterday. I have no objections to the hedge being cut/reduced in height and I look forward to it being re-generated for the benefit of all. There is only one household that may object because to my knowledge their part of the hedge is looking ok, we shall see. (Number 2 Stagshorn Rd)
- Whilst I agree that the boundary hedge in some parts of the recreation ground is in need of being reduced in height and replenishing with new hedging, I have issues regarding any work being carried out to the hedge at the rear of my property.
 - As you face the hedge from the recreation ground my house is the third property from the right hand side. My wife and I have lived here for 36 years and understand that the **hedge** / **boundary are legally shared.** At the time of moving here the hedge consisted of a few small stubs of Hawthorn and a gate opening which served one of the bungalows, which was demolished to allow for the new development. We nurtured, planted new hedging and have maintained the hedge ever since.

Three years ago my wife and I carried out repairs and replanting to our complete hedge. This involved not only being left with a large amount of dead hedging but also a cost of £500.00 to by new mature Pyracantha and Hawthorn hedging.


As there was so much waste to deposit, I visited the Parish Council Office in Blendworth Lane and asked the Grounds Manager if the council would help in getting rid of the waste and offered to pay. I was told this was NOT something the council undertook. Therefore my wife and I had to shred this and take it to the house hold waste tip at Waterlooville at our cost.

I have kept the hedge trimmed and behind the line of the adjacent hedge and it is currently 2.4m/8ft High and gradually thickening. This helps to keep any over hit footballs entering

STAGSHORN ROAD SIDE - PROPERTY BOUNDARY











PRINCESS GARDENS SIDE - BOUNDARY

Dear resident.

You probably know that annually (around September time) Horndean Parish Council have cut the hedge that borders your property and Five Heads Rec.

Some parts of the hedge are now starting to die and collapse and because of this, during the next cut I am looking into the option of lowering the hedge to approx. 7 feet in height. The main reason I want to lower the hedge is so I can clear out any dead areas and replant the dead gaps with new species. Lowering the hedge will allow more light into the hedge allowing any new plants a better chance of growing.

As your property backs onto The Rec I am seeking the opinions of the residents as you are the people most affected by the hedge, its height and the protection it provides


I have added a couple of pictures to give an estimated finished height of the cut hedge.


Please be aware, large gaps may appear in the hedge as we remove the dead sections and it may take time for any new plants to grow and establish enough to fill the gaps as before.
