Cllr Mrs E Tickell proposed to accept quote 1 with the instruction that the ash tree works are not to be undertaken until ownership has been established. This was seconded by Cllr B Raymond.

I work with David and Elaine on the climate panel at East Hants and have been asked to investigate whether there are any areas in the Southern Parishes, including those owned by HPC, that might be suitable for developing in the following ways:

- 1) Open green space (with potential for wildflower growing and/or local community gardening) similar to 'pocket parks'
- 2) Areas that might be suitable for the tree-planting program at EHDC (where there is an effort to plant one tree for every resident in the district)
- 3) Other aligned open space/open use areas

I understand that a number of years ago there was a transfer of the smaller/isolated sites that EHDC owned in Horndean to the Parish. As such EHDC do not have these smaller parcels in our area, in the same way that they do in the other parts of the district, and there is a desire to see whether we can work together to develop some of these projects to benefit residents.

SUBJECT TITLE: Memorial Benches

PURPOSE OF REPORT: To discuss Memorial Benches

I have had two requests for memorial benches around the Parish. One for Catherington Lith and the other for Sheppard Close.

This report is to open up a conversation about Memorial benches and discuss the way forward.

I have attached a design and a costing for a green oak bench but I have not managed to source a price for engraving. I used this design at my previous job and the benches are very sturdy, easy to make and easy to install without the need for concrete due to their long legs.

There are 2 options for engraving: 1 a plaque that the resident can source and pay for which we attach to the bench or the bench can be engraved directly into the wood (if we can source a local engraver).

My thoughts:

- Benches would be a good addition to the sites we manage. We often receive comments about the need for more benches.
- Wooden benches are more in keeping with the Countryside Sites.
- Oak is a strong material for benches and should last well.
- We should stick to one bench design as too many different designs starts to look untidy.
- HPC choose the suitable locations for benches on each site.
- HPC would need to limit benches in areas/site.
- HPC could maintain the bench for 5 years. After that, if the bench becomes damaged/unfit for use it can be removed.
- It should be the bench owner's responsibility to keep us up to date with contact details if
 we need to contact them about a replacement bench. If we cannot contact the individual,
 the bench space can be used by someone else.
- We paint the bench with dark oak paint when purchased and every 2 or 3 years after to help keep it maintained and looking fit for purpose.


Some councils have guides/policies regarding memorial benches that can be read for further ideas.

SUBJECT OF REPORT: Countryside Team Update

The following projects and significant works have been undertaken since the meeting of the Grounds Committee on the 25 January 2021:

- Catherington Lith replanted with assistance from volunteers. In the region of 950 trees
 planted by the end of March, with a further 40 being provided by a go-green scheme
 supported by our photocopier supplier.
- Catherington Lith boundary fence installed
- Hillview reinstatement of land
- RoSPA play area report all recommendations as appropriate completed
- Applications to HCC/SSE for permission to enable flower baskets to be located within the village have been submitted - delay due to a new requirement for weight testing
- The removal of bramble and hawthorn on Catherington Down.

Planned projects:

- Tree works areas within Catherington Lith residual cosmetic work to be undertaken following completion of contract
- Removal of two large dens built in Yeolls Copse
- Tree carving within Catherington Lith and Yeolls Copse should commence approximately on the 10 May 2021.
